# INDEPENDENT AUDITOR'S REPORT

To the Members of THE TRIVANDRUM CHAMBER OF COMMERCE AND INDUSTRY

Report on the Audit of the Standalone Financial Statements

#### Opinion

We have audited the accompanying Standalone financial statements of *THE TRIVANDRUM* CHAMBER OF COMMERCE AND INDUSTRY ("the Company") which comprise the Balance Sheet as at March 31, 2023, the Statement of Profit and Loss for the year then ended, and a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid Standalone financial statements give the information required by the Act in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2023, and its **Profit** for the year ended on that date.

## **Basis for Opinion**

We conducted our audit in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Companies Act, 2013. - 1) We refer in Note No.1-Notes forming part of financial statements, The Trivandrum Chamber of Commerce and Industry is a Non-Trading Company incorporated in 1951, under the Non Trading Companies Act, 1961, the audit and annual returns are only to be complied as per the Companies, Act 2013 with the Registrar, Non-Trading Company, Kerala, and not with the Registrar of Companies as per the Companies, Act, 2013.
- 2) We refer in Note No.2.c- Tangible and Intangible Fixed assets and Depreciation, Chamber is continuously following Depreciation as per the rates as prescribed in Income Tax Act, 1961 and no revaluation done during the year. As per Schedule II of Companies Act 2013, useful lives to compute depreciation have been brought into effect from 1st April 2014.

#### Information Other than the Financial Statements and Auditor's Report Thereon:

The Company's Board of Directors is responsible for the preparation of the other information. The other information comprises the information included in the Management Discussion and Analysis, Board's Report including Annexure to Board's Report, Business Responsibility Report, Corporate Governance and Shareholder's Information, but does not include the Financial Statements and our auditor's report thereon.

Our opinion on the Financial Statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained during the course of our audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

From the matters communicated with those charged with governance, we determine those matters that were of most significance in the audit of the financial statements of the current period and are therefore the key audit matters. We describe these matters in our auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

# 1. Corporate Information

The Trivandrum Chamber of Commerce and Industry is a Non-Trading Company incorporated in 1951, under the Non Trading Companies Act, 1961, the audit and annual returns are to be complied as per the Companies, Act 2013 with the Registrar, Non-Trading Company, Kerala and not with the Registrar of Companies as per the Companies, Act, 2013.

# 2. Significant Accounting Policies

# a) Basis of Accounting and Preparation of Financial statements

Although these estimates are based on management's best knowledge of current events and actions, uncertainty about these assumptions and estimates could result in the outcomes requiring a material adjustment to the carrying amounts of assets or liabilities in future periods.

# c) Tangible and Intangible Fixed assets and Depreciation

#### **Fixed Assets**

#### f) Investments

Current Investments will be carried individually and the same will be valued at cost. However, there are no Investments during the year.

# g) Cash and Cash Equivalents

Cash and cash equivalents comprise cash at Bank and in hand.

#### h) Provisions

A provision is recognized when the company has a present obligation as a result of past event; it is probable that an outflow of resources will be required to settle the obligation, in respect of which a reliable estimate can be made. Provisions are not discounted to their present value and are determined based on
