



President's Message



Dear Members.

CCI has been providing comprehensive support to its Members including intervention in various business, industrial and development issues that have reinvigorated the business and industrial sectors of the Capital City and Region.

Our contribution for the development of Thiruvananthapuram International Airport has enhanced Domestic and International connectivity resulting in an increase in flights, which has gone up from 40 to 104 with 15,000 passengers traveling a day as against 5000 privatisation. We are also coordinating with the Government to acquire additional land to satisfy the Statutory requirements of the Runway End Safety Area (RESA).

A historic moment was witnessed with the flagging in of the first ship to Vizhinjam Port, carrying the first of the 32 cranes. All 31 other cranes have been erected, with the breakwater and berth completed. The trial ship is expected by the end of June. The second and third Phase of the Vizhinjam is expected to take off soon. TCCI played a proactive role in overcoming protests and other

obstacles to ensure the project's success, which is nearing Commissioning.

On railway development and metro initiatives, our efforts have led to the development of Thiruvananthapuram Central Railway Station, Trivandrum North-Kochuveli, and Trivandrum South-Nemom Terminal. We have intervened and raised our concerns about the proposal by KMRL to downgrade our Metro Project to a LightTram Metro, especially when all studies have been completed for a Metro. We have also taken up the issue with the Railway about the possibility to take two AC bogies to the Jan Shatabdi Express to be run on a pro-rata basis after refurbishment.

Persistently we are following up for the several Highway Road Projects connecting the Capital District, ensuring improved infrastructure and connectivity.

Suggestions that need to be included in their respective Election Manifesto for the development of Trivandrum were given to all the Political Parties and also engaged them in the Meet the Candidate Program.

Today, TCCI is looked on by the Public to advocate and guide the development activities related to the Capital City, District and Region. Our sincere efforts are further affirmed by the Media giving importance to our role and the Government seeking our involvement and support in all the related area.

The recognition to our work was acknowledged recently by the Trivandrum Management Association (TMA) with the 'Trivandrum Development Award' which was received from the Hon'ble Governor, Shri Arif Mohammed Khan. This Award is dedicated to all the Citizens of Trivandrum who stood and supported TCCI, TATF and Awake Trivandrum for all our development



initiatives.

A Chamber of Commerce is an important fabric for any City and we have been able to live up to the expectations at the National and International levels, as evidenced by our interactions with the US Consul General, the Yukon Delegates of Canada, Members of the Soft Power Club from Italy under the leadership of India's G20 Sherpa and former NITI Aayog CEO Shri Amitabh Kant IAS(Retd), Hon'ble Member of NITI Aayog Dr. Arvind Virmani, and the Dubai Chamber of Commerce. The invitations to enter into MOUs with various International Chambers of Commerce are being processed and will be executed soon. We propose to visit UAE and other countries for this and also to attract Investments to Trivandrum and invite them. to be our Members.

Despite an increased in Membership Fee to ensure the quality of the Members, we have successfully added 19 new Members during this term, reflecting the growing trust and confidence in TCCI's leadership and vision.

From our activities over the past years, we are confident to say that TCCI has played a pivotal role in steering the growth and development of the Capital City and Region. Our unwavering commitment to our Members and Public to enhance connectivity, Infrastructure development have started paving the way to make Trivandrum as an Investment destination.

Together, we will build a sustainable Capital City and Region and strive for even greater accomplishments in the years to come.

MINUTES OF THE 69th ANNUAL GENERAL BODY MEETING (AGM) OF TCCI HELD ON 30th JUNE 2023 AT 5:30 PM

I. Prayer

The Chamber Prayer song was played.

2. Calling the Meeting to Order

Meeting was called to Order by President S N Raghuchandran Nair at 5:30 pm.

3. Welcome & Presidential Address

President welcomed all the Members and informed the following:

- a) TCCI had filed a Case in the High Court pointing out that the hardships and losses caused to the public and businesses due to the strike on public roads at Secretariat and Raj Bhavan. It was decided to Appeal against the Verdict which has not considered all our Prayer.
- b) TCCI has decided to put pressure on the Government to expedite the process of acquiring 18 acres of land required for the Trivandrum Airport expansion. Based on these facts, he emphasised the importance of this Project for augmenting the growth of Trivandrum. In addition, another 12 acres of Land to be acquired on the Chakai side for compliance of RESA (Runway End Safety Area) and parallel Taxi way etc. requirements, failing which our Airport can be downgraded restricts wide bodied air crafts.

Despite significant progress in Airport development and flight services, we are constantly in discussions with the Adani Group to address the issues relating to the connectivity, especially relating to fares and timings.

- c) It is expected that the operations of Vizhinjam Port will start before May 2024. As part of this, the first ship Carrys the machinery by expected in the month of October/November this year. It has also been brought to the attention of the Authorities to take necessary steps to build the compound wall around the Harbour and relocate the 'Cross' of the Church to a convenient location after mutual discussions with the Church.
- d) The Trivandrum Development Master Plan, existing since 1971, has been updated and the new one is being uploaded on the Website, He requested the Members to go through and evaluate it separately with the suggested changes.
- e) He explained the facts, status and involvement of TCCI on the various ongoing and upcoming development works in Thiruvananthapuram City, such as Airport, Vizhinjam Port, Railway Station development (Nemom and Kochuveli), Trivandrum Mobility Hub, 'Arteria', Technopark development, Trivandrum Smart City Project, Chithranjali Film City Project, Inland Water Ways Project, Techno City, High Court Bench, Trivandrum Metro, AIIMS, Highway Connectivity, Chala Walking Street Project, Greenfield Stadium etc.





f) He called upon all the Members to be more active and be part of TCCI Membership WhatsApp Group so as to keep abreast the developments happening with Industry.

4. 68th Annual Report

Secretary Shri Abraham Thomas (Joji) presented the 68th Annual Report which was printed and circulated earlier. There was taken as read, adopted and approved.

5. Confirmation of Meeting of AGM held on 30th June 2022.

Minutes of the General Body Meeting (AGM) held on 30th June 2022 was confirmed and passed.

6. Audited Statement of Accounts and Balance Sheet 2022-2023

Treasurer Shri. Ranjit Karthikeyan presented the Audited Statement of Accounts and Balance Sheet for the period ended 31st March 2023 (circulated in advance) which were also approved and passed.

He also explained regarding the delay/regularization/renewal of Registration of TCCI with the Kerala Registrar of Non-Trading Organizations in filing the Annual Returns (2010-2019) was since has been renewed with a penalty of Rs.2,06,000/-. Steps are being taken to File our Returns from the 2019 to 2023 after the AGM.

7. Appointment of Auditor for 2023-2024

Resolved that Shri G S Unnikrishnan, M/s ARJUS & Associates, TC 23/1434, 'Anjali', Golf Links Road, Kowdiar P.O, Trivandrum - 695 003, be appointed as Auditor of TCCI for 2023-2024, at a remuneration of INR 15,000/- (Rupees Fifteen Thousand Only) per annum.

8. Transact such other business of which due Notice is given None

9. Any other matter with the permission of the Chair

- a) Shri P Ganesh: Suggested organizing a Trade Fair under the auspices of TCCI for a period of at least six months within Thiruvananthapuram City or within a radius of 20 km. This initiative would provide a platform for businesses in Thiruvananthapuram to market their products and services, consequently fostering the growth of MSME Enterprises. Additionally, he proposed the establishment of Data Storage Centers, which are likely to attract investments from many multinational companies to Trivandrum.
- b) Shri M.R. Narayanan: Suggested that if TCCI finds a suitable place to hold exhibitions and rents it out at reasonable rates, it will generate revenue for TCCI and provide assistance to the Traders. He also mentioned that when the Vizhinjam Port becomes a reality, the benefits accruing from it should be communicated to the public and business communities. He emphasized that the Government has not adequately coordinated necessary activities, and TCCI should take up the task of coordination.



- c) Shri S.N. Raghuchandran Nair: Informed the General Body that Trivandrum has a golden opportunity for investors and businesses in the Warehousing sector.
- d) Shri CA Ranjit Karthikeyan M R: TCCl should promote Open Network for Digital Commerce (ONDC), a Govt. backed e-commerce initiative, which creates a network of interconnected e-marketplaces that makes it easier for small store-owners to tap demand online. He opined that this would be a platform that would be less expensive, more effective and reach people than finding a place and conducting a Trade Fair.
- e) Dr P S Thaha: Steps should be taken by TCCI to remove the ambiguities and confusions of the Trivandrum Master Plan.
- f) Shri Nanoo Viswanath: TCCI should work closely with organizations such as FICCI and FIEO, which are the lead Organizations of most of the Bilateral and Multilateral Trade Treaties and take all its advantages available on trade and industry.
- g) Shri Ambadi Chandrashekaran Nair: TCCI should take necessary steps to rename the Kochuveli and Nemom Railway Terminals as Trivandrum South and Trivandrum North respectively at the earlier to which President informed to him has been taken up.
- h) Shri Pradeep Kumar: Informed about KSSIA promoted Company called Kid Infrastructure Pvt Ltd and invited interested investors.
- I) The Prayer Song 'Vanchi Bhoomi...' shortened to 49 seconds has been approved as the Official Prayer Song of TCCI.
- j) TCCI's redesigned Logo as seen below has been adopted.





k) President informed and explained about TCCI Business Excellence Awards:

Shri Suresh Mathew, Vice- President of TCCI, Chairman of the Award Committee has submitted guidelines for the Business Excellence Awards. He has suggested the following three categories:

- I. Chamber Excellence Award- To Promote and Recognize TCCI Members.
- 2. Golden Chamber Award To felicitate Entrepreneurs who have invested more than INR 100 crore in the Capital Region with creation of substantial employment opportunities.
- 3. Platinum Chamber Award To honour Policy Makers/ Legislators/ Bureaucrats/ Business men who had contributed for the growth of the Capital Region, by bringing Projects worth INR 1000 crores or more.

The Chairman of the Award Committee was authorized to proceed with the Proposal.

- b) Shri Sunlal: Requested all Members to co-operate by giving updated Member's information and advertising in the Members' Directory. He suggested to fill the prescribed Forms and submit it to the Office as the earliest.
- j) Shri I A Peter: Requested TCCI to bring the issues related to construction of Compound wall around Veli Industrial Park to the attention of the Government.

- We refer in Note No.1- Notes forming part of financial statements, The Trivandrum Chamber of Commerce and Industry is a Non-Trading Company incorporated in 1951, under the Non Trading Companies Act 1961, the audit and annual returns are only to be complied as per the Companies, Act 2013 with the Registrar, Non- Trading Company, Kerala and not with the Registrar of Companies as per the Companies, Act, 2013.
- 2. We refer in Note No.2- Tangible and Intangible Fixed assets and Depreciation, Chamber is continuously following Depreciation as per the rates as prescribed in Income Tax Act 1961 and no revaluation done during the year. As per the Schedule II of Companies Act 2013, useful lives to compute depreciation have been brought into effect from 1st April 2014.

Information Other than the Financial Statements and Auditor's Report Thereon:

The Company's Board of Directors is responsible for the preparation of the other information. The other information comprises the information included in the Management Discussion and Analysis, Board's Report including Annexure to Board's Report, Business Responsibility Report, Corporate Governance and Shareholder's Information, but does not include the Financial Statements and our auditor's report thereon.

Our opinion on the Financial Statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is





materially inconsistent with the financial statements or our knowledge obtained during the course of our audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information; we are required to report that fact. We have nothing to report in this regard.

1) Corporate Information


